

SCHEDULE 11 - MUNICIPAL SOLID WASTE LANDFILLS

Each affected facility shall be assessed a permit fee based upon the permitted footprint size of the facility as specified by the governing Local Enforcement Agency. Beginning January 1, 2007, this permit fee will be adjusted annually by multiplying the base permit fee for the previous year by the average percentage rate for the month of August of the previous year (rounded to the nearest half dollar) which is derived by a fraction, the numerator of which is the Revised Consumer Price Index for All Urban Consumers as published by the United States Department of Labor, Bureau of Labor Statistics for All Consumers for the Rural Service Area #7 statistical area (All Items, Base 1982-84 = 100), (the "CPI"), and the denominator of which is the CPI for the same calendar month of the prior year. Notwithstanding the foregoing, in no event shall the permit fee be decreased and in no event shall any increase exceed 4% per annum, without formal action by the Air Pollution Control District Board. In determining this fee, the following schedule shall be utilized:
